DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This house is of stone and frame, in two parts. It faces north. The ridge line running east-west. Small in scale. The house has 2 bays by 1 in the stone section, 2x1 in frame, placed end to end. under an A frame roofline. Windows have 6 lights over 6. Two chimneys <sup>one each</sup> at the ends of the house are flush, interior. In soapstone near the peak of the roof is a datestone 1817. An older part of the house where the frame stands now was built in 1804.
