This large frame ^{clapboard} ~~frame~~ house is typical of homes across Harps County. Three bays across the front, an uneven number of windows on the sides. The house faces west, the ridge line runs north-south with a ridge high corner in the west.

2 1/2 stories, ~~a~~ interior chimney ^{emerges} at the center of the ridge line, ~~resist~~ ^{resist} from room heaters and stoves later replaced by central furnace.

A lean-to roof to the east at the back of the house adds a utility area.
