DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This stone and frame house, now very close to the road, faces southeast. The two story dwelling is built into the bank of a steep hill. The original entrance emphasis has been changed as ground level has built up. The original principal entrance has been concealed by the rising ground level and the placement of a porch.

The stone section of this house is two stories high and two bays long. The stone is of ashlar bond. Large portions of this unit's walls have been painted with black, white, and grey paint and each rock is outlined with black paint. Though this section was probably always partially underground, the dirt appears to have built up more through the years to the extent that the openings on the first elevation of this section are barely so.

Windows in this unit are six lights over six. There is one on the southeast side and one on the northeast side of the first elevation. The door on the southeast side has beaded trim. There are no windows or doors on the northwest facade's first elevation as it is completely subterranean. The second elevation's windows are also six lights over six. This unit's roof is gable flank, covered with asphalt shingles and has a box cornice.

The interior of this section is deteriorated on the first elevation. Because of its subterranean position this level has been little used in what seems to be many years. The plastered walls are peeling. A beaded chair rail is on each wall. Moulded cornices trim the ceiling. An enclosed, winding stairway is located on the northeast wall. This leads to the second elevation, but has been closed up. Next to this is a closet. Doors are pegged here. The fireplace on this wall has moulded colonettes, paneled end blocks, bed mouldings and a mantle shelf. A pegged coat rack runs along the southwest wall.

At the second elevation, there is not much left to see. The floor has been tiled and if there was a fireplace on the northeast wall it has been closed up now. Walls and ceiling are still plastered.

The attic of this section has pegged log beams. The logs have been squared at the end. Vertical lathing is visible on the southwest wall under flaking plaster. Four light casement windows are at the northeast gable end. Floors are of random width pine.

The frame unit of this house is three bays long and two stories high. It is built onto a high, lighted, stone basement.

A gable flank roof has a wide stuccoed chimney at the northeast inside gable end. Entrance is in the center bay of the southeast and the northwest facade.

Many of this dwelling's unique characteristics are disguised now through an attempt to modernize the structure. The main room of the stone unit, at the ground level, has been completely ignored and much of the fine wood work will soon be in ruins.

This section's basement is on the same elevation as the stone unit's first floor. This has a small room with shelf lined walls which must have been intended for the storage of canned goods. A large, brick faced fireplace is located in the center of the northeast wall. This originally was stone faced and lined. It appears to have been a cooking fireplace. Windows at the basement level are 6 by 6. A beaded plank door is at the center bay. It has iron strap hinges.

The first elevation of this section has moulded chair rails and its doors appear to be very old. The doors have old iron strap hinges and are of moulded panel. Old iron box locks are on each door. The living room's fireplace has been refaced, the ceilings have been lowered, and the floor, tiled. The stairway is enclosed, having a moulded panel door at its entrance.

Upstairs this section has plastered walls, covered, in some instances, with vertical beaded boards of random width. Beaded beams are visible. A simple cornice trims sections of the northeast room's ceiling. Closets in that room have pegged doors with iron "HL" hinges.

Hughes House Murder*

Near Norrisville, at the foot of Bald Hill, sits an old stone house, the ancestral home of Zenas Hughes and his family 100 years ago. The old house was once a tavern, the haunt of rugged men and stopping place for travelers, sometimes of questionable morals and behavior.

One night, as several men were playing cards in the large third-floor room, an argument arose and hot words were exchanged. A tall muscular man seized a heavy chair and brought it down upon the head of the short, stocky man at his right. There was a thud and the body lay on the floor in a pool of blood.

The murderer disappeared and the incident was forgotten. In later years, a new family moved in, and the first task of the immaculate housekeeper was to scrub the floors. The third story shone in sparkling cleanliness except for one spot. The blood on the attic floor could not be scrubbed off. The owner painted the floor, but the blood stains came through. Not being of a superstitious nature, she paid little attention to the neighborhood stories of a haunted house.

One day, while busy at her ironing board, she heard a muffled sound overhead. The sound continued and, with thud after thud, the sound seemed to descend the stairway and knock on the closed door.

She told her neighbors, and to prove her fears groundless, a bold young man agreed to sleep in the haunted attic that night. He had just dozed into a half-sleep when he felt the covers of his bed slide slowly across his body toward the door. In the dim moonlight, as if pulled by an unseen hand, he saw the bed covers settle squarely over the blood stain on the floor.

Without further ado, he rose and dashed down the stairs and onto the porch. His startled eyes saw a strange, misty shape float out over the surrounding swamp. In the awful stillness of the night, the voice was clearly audible as it screamed the name of the murderer of long ago.

The stone section, northeast, is a bank house, 2 bays by 1 room deep. The basement a full story on the southeast side. The brick-topped chimney ^{in the northeast} rises from a cooking fireplace in the basement, now closed off.

The frame section, 2 stories, 2 bays by 2, also has a chimney in the northeast end.

Windows throughout are 6 lights over 6. Each section has its one-story porch on the southeast side, leaving windows clear on the upper floor.






