DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small log building is built upon a hillside overlooking Deer Creek, facing towards the north. It is a one-story structure, built of chinked log and left pretty much in it's original state. There are two openings on each side, and below the walls is a high, exposed, stone foundation. The windows themselves have no sashes. One door is located on the northern facade, while the other is on the western side, leading into the cellar. The roof is the only altered part of the house, being gable-flank and covered with tar paper. A brick chimney is located on the northern inside-end of the roof.

STATEMENT OF SIGNIFICANCE

This structure is reputed to be one of the oldest known log buildings in Harford County. It was built on a 115-acre tract called "Black Rock", granted to the McKemson Brothers by the lord proprietor in 1771. In 1781, the proierty and the cabin were purchased by Matthew Wiley, Sr., and it continued to belong to the several generations of Wiley millers from the late 1700's throughout the Nineteenth Century. The 1878 Martenet map indicates that one Thomas Cordery, probably a tenant, was occupying the cabin at that time.
