DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The well-proportioned brick house is situated near a small stream between the barn* and the springhouse* on a little road - the only place in the valley.

Four bays by two, ^{two stories} the house faces south, the ^{slate roof} ridge line running east-west between large multiple-flue chimneys at each end of the house: each interior room has a fireplace. Windows have six lights over six throughout except in the gable ends where small quarter-circles fan out from the chimneys in the attic.

There is a one-story porch across the south side of the house

Built along classic lines and plans at least a hundred years after many other houses of this type, a datestone of 1856 is in the chimney. The journal ~~is~~ is maintained by Mrs Webster's son (HA 476) whose house is off Grace ton on the same tract; The present owner, Mrs Webster is descended from the builder Whiteford Dallan. She has always lived here.
