The Pomraney house may have been built in three sections, certainly two. A small one-story house with a large chimney was added to at its west end by a 2 story 5 x 2 bay house that may have two parts.

Facing south, roof ridge line runs east-west. ~~Asphalt~~ asphalt shingle covers all materials; ~~the small section may be of log~~

Windows throughout are 6 over 6 lights. The roofs are slate.

The large section has a one-story porch across the south wall. A chimney rises from perhaps the center wall, one westward of the building. The small section, covered by clapboard in the 1920's, may have log construction. No large fireplace remains.
