Unique frame house, clapboard ~~finished~~ ^{covered} with asphalt shingles. In two parts, both face south, the ridge line running east-west, a one story porch running along the south side, the posts decorated with ~~the~~ fancy cut wood.

The east section is $1\frac{1}{2}$ stories 3 bays by 1 with lean to additions at the rear. A ~~gable facing south~~ ^{gable facing south} has a double window in the upper floor.

The west section is two stories, 2 bays by 2, there is a chimney rising from a large fireplace at the east end.

The scale of the whole place is small.
