A smaller section, ~~probably not older since it is~~ ~~on left side~~ but without the solid cornerstones of the main house, is one storied, 1 bay x 1. ^{A hidden cedar block addition, 1 story, is on the east side.}

The house faces west. The gable roof ridge line runs north-south. A large chimney is inside the north wall of the main house.
