In two parts, the larger, south section is 3 bays x 1, two stories, with a fireplace at each end, flush, inside.

The smaller section to the north has a ~~corner~~ chimney <sup>in the north west corner</sup> a lean to-roof slanting east from a ridge line to the west.

Foundations are stone. Windows 2 over 2.
