DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This stone masonry house is located at the end of a long lane off Patterson Mill Road near Emmorton in a concealing setting. The house faces south.

The rubble stone structure is two stories high and has stucco on all but the south (front) facade. It is three bays by two with the principal entrance forming a center through hall. The principal entrance has a vertical panelled door with a four light transom overhead. The door is flanked by two windows having six lights over six. These windows have stone lintels and beaded frames. A one bay entrance porch is located at the main entrance and although the porch itself does not appear to be original the gable front pediment is very old. Two corbeled brick chimneys are flush with the gable ends of this house. The gable flank roof has a box cornice and is covered with slate shingles. There is a basement under the house and horizontal bar windows.

A one bay, enclosed entrance way is located on the east facade. This is also of rubble stone covered with stucco.

This house is laid out in a classic central hall floor plan with two rooms on either side. An open stair is present in the north east corner of the through hall. This straight stair has one landing. Walls are plastered throughout the house. Most interior doors have vertical wood panels. Floors on the first floor are oak and on the second floor, pine. These floors, though probably not original, are definitely old. The kitchen is located in the north east room. An enclosed, winding stairway is within the west walls of this room. It is no longer used. Fireplaces in this house are diagonal and seem to be of the Rumford type. Located in the center of each gable end of the house, these brick lined fireplaces are double faced and triangular in shape. The mantles have wood moulding.

HA-535 Kracke's Stone barn

This rubble stone barn is located south west of the dwelling. It is rectangular in shape and one story high. Its roof is tin covered and wide wooden plank doors are located on both the east and west sides.

STATEMENT OF SIGNIFICANCE

The property of which this house and barn stand consists of portions of two tracts, Gillingham and Gibson's Range (Ridge). The tracts were granted in 1684 and 1683 respectively. Records for both the 1798 federal tax list and the 1814 tax list are incomplete and only one mention of any property owned by Edward Tredway (grantor of this property in 1814 to William Sawyer) was made. An Edward Tredway is listed as having owned 134 acres in the Bush River Lower Hundred with a house.

Architecturally, this house is of simple design with its two stories and center hall floor plan. It was built as a simple, sturdy farm house and it has stood for almost two hundred years.

Fireplaces in this house are interesting though not uncommon in this area, probably those invented by Lord Rumford.


