Two-story frame clapboard house made into a store. L shaped.

Three bays, ~~by two~~ facing south, the first floor is altered into 2' bay windows flanking a door under a shallow overhanging roof, ~~both~~ side windows downstairs closed off for shel-space. A rear wing runs north along the east wall 1 bay x 1 with a lean-to 1 1/2 stories north of that.

One chimney rises at the west end of the A roof, ^{whose} ridgepole runs east-west.
