This log house is being restored by owners who are carefully stripping off the clapboard and re-painting the chinking, but who choose to paint the logs and stone foundation dark red, leaving ^{conspicuous} white stripes ~~between~~ between the logs.

The bank - basement of stone has a door and a window facing south. A door in the one story log house above must have been cut down to a porch, now removed. A window on either side has one left over one.

There is a large stone chimney in the east wall rising from a basement fireplace. The asphalt shingle roof/ridge runs east-west.
