DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two-story structure facing northwards, with a southeast wing and a southwestern addition. The walls are bevelled frame, placed on a low stone foundation. The house is four bays by four overall, with the addition being two bays by one. The windows are 2 X 2 on the north face of the house, but are 6 X 6 elsewhere, including the attic windows at the ends of the eastern and western gables. The panelled shutters on the first floor look to be original. The main entrance is situated on the northern facade, a second egress is located on the western embrasure near the rear, while a third door is located on the southern side of the shed addition. Most of the doors and windows have been replaced, although the doors have retained some of the original hardware. The main entrance has a transom and side lights, all two-pane. One large dormer, actually the extended gable, is positioned on the eastern side of the wing, featuring a 2 X 2 arched window. Two other dormers, with unusual arched roofs and architrave trim, are located on the northern side. Their windows are 6 X 6. The gable-flank roof has asphalt shingling, as well as new soffits and eaves. The single porch is on the north side, a three-bay affair with column brackets and dentil trim as well as a shed roof. The three brick chimneys are original, with two on the interior ridgeline of the wing and the third near the western end of the main section on the inside end. Cellar openings are visible on the western and southern sides, and the cellar door is on the south side of the wing.

The barn also faces the north, constructed of vertical frame with a stone foundation. The roof is a gable front, with shed wings on either side.

STATEMENT OF SIGNIFICANCE

The house is located on the part of the tract called "Eaton", which was patented by John Larkin in 1679. Thomas White and his son, William, owned the tract from 1761 to 1795, with it measuring 437 acres according to the 1783 tax list. Gideon Dennison owned the land from 1795 until the early 1820's, he being one of the largest landholders around with 1820 acres. The house is not nearly as old as the tract, probably 100 years, more or less. The 1878 Martenet map shows the owner to be one Isaac Stillwell, but for the next eighty years the property was in the hands of the Macklem family whose one member, John, operated the Rock Run Mill at the turn of the century.

HDG	31	151	Otho Scott was appointed as trustee for the tract after an 1837 court case involving William Sappington v.s. Jane and Phebe Bell, and in 1845, Scott sold the property to Henry Barnes. This tract had been previously owned by John Bell, who in turn had purchased the land from Henry Wilkinson and James Botts. The tract measured 150 acres, more or less, and consisted of portions of Eaton, Eaton's Second Addition, Tripple Union and Quaker Bottom.
HD	9	325	1. In 1826, James Botts sold to John Bell a portion of the larger tract which was derived from the following two sources.
HD	U	263	a. In 1809, Elizabeth Jarrett and Margaret Robinson sold a one acre, 13 perch lot to James Botts.
HD	9	324	b. The rest of Botts' contribution consisted of 25 acres and 46 perches and was once part of Jerusha Dennison's Eaton and Eaton's Second Addition, already discussed.

- HD 10 239 2. In 1826, Henry Wilkinson sold parts of Eaton and Eaton's Second Addition, totalling 84 $\frac{1}{2}$ acres, more or less, to John Bell. Wilkinson had acquired the land from Dr. Benjamin Butler, who in turn had acquired the property from Jerusha Dennison.
- ALJ 7 278 Mitchell
 In 1850, Bernard Mitchell sold a tract of 97 acres, three roods and 12 perches to John Tweed. This was part of Eaton and Eaton's Addition.
- WD 34 411 In 1848, Eliza Henly and Robert S. Rodgers sold a 680-acre portion of Eaton to Bernard Mitchell.
- HDG 33 194 Alexander J. Wadsworth sold 637 acres of Eaton and Eaton's First and Second Addition to Robert S. Rodgers in 1847. Butler and obtained this property from Gideon Dennison, son of Jerusha Dennison.
- JLG M 602 In 1795, William White sold the same three tracts to Gideon Dennison. The deed mentions that Eaton was patented by John Larkin in 1679. Larkin sold Eaton to James Phillips, and grandson James sold it to Thomas White in 1761. The two additions had been patented and retained by the White family.




