 Victorian taste for ornate detail found in the lavishly decorated cut-wood eaves with three tiers of Gothic arches beside a rose window in the gable end south, in the ~~very narrow lap~~ planking with three half-round grooves made to resemble narrow planking, and the Tiffany glass windows.
