DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Frame house in 3 parts, asphalt shingle covering clapboard. (or perhaps log in part). A long oblong, the house is 2 stories thruout but part C (see sketch) has a higher roof ridge line, higher ceilings. Ridge line run east-west, the house faces south.

Each section is basically 2 bays, 1 room deep. An addition to the north in Part B adds a small room, and enclosed porches to Part A and to the combined BC add living and ~~work~~ utility space.

Windows downstairs thruout are 6 lights over 6, but vary upstairs: Part A ~~3~~ over 6, Part B 3 over 3, Part C 6 over 6.

(If part B is the oldest, with smaller windows spaced a little wider and a large fireplace, it may be that these walls are basically log.)


