Stone and frame house, T shaped, 2 stories, the entrance on the south side of the stem of the T, or the stone section. The frame part lies westward, the roof ridge line running north-south.

The stone part is 2 bays x 1 upstairs, 3 bays x 1 down, 3 lights over 1 in the windows. One chimney rises from fireplaces in the west end wall of this section. Stonemasonry somewhat crude.

The frame part has aluminum siding over clapboard. Windows, unevenly spaced, are generally small, of various types of glazing, and here and there are two frames in one opening, double hung. Perhaps this section was built ~~several~~ in several ages.
