

A sloped log and frame house covered with clapboard. Facing east a one-story porch shelters the four bays (3 windows and a door) of the old house. An addition to the south end of the house brings that wall flush with the wing running west 1 bay by 2. A one-story lean-to adds storage space to the ~~skilled~~ west end.

Windows have 6 lights over 6 throughout except for the kitchen where a long narrow double-hung window, 4 over 4, is over the sink to the south. Four double-hung 6 over 6 sashes in one opening kept the south wall of the dining area.
