Once a country store, this frame building has asphalt shingles covering clapboard. L Shaped, 2 stories, the corner of the L is southeast, the two entrances to the house are on the north walls, each under a one story porch. The pitched rooflines are broken by two chimneys each flush with the ^{west} walls. Windows have 6 lights on 6.

The wing running north along the east wall appears to be of a somewhat later style, hence it seems safe to assume that the store was added to an older house near the corner.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

A country store ~~was~~ failed as roads and cars improved in the 1930's, was revived again during World War II when travel was curtailed, and stores were chosen for local convenience, to fail again in the mid-40's when larger choice and lower prices again became accessible in the large stores in town.

Now a large house, too close to the road, the owners do not find it worthwhile to rebuild it a smaller size.
