Facing south, the peaked roof ridge line runs east-west, with wide eaves and a fancy cut-nail work eaves treatment. Windows have 2 lights over 2 except ^{the} flat dormers have two sashes each with 4 lights in each sash. There is one chimney at the center of the house.

Its condition is deplorable (altho the front porch fell off and had to be replaced with a shelter ~~structure~~ smaller than the original, a much-needed paint-job is still undone after almost three years.)
