One story high with a window in the ^{west} end wall lighted the attic, it is 3 days by one, facing north, the A-roof ridgetime running east-west, ~~with~~ with a lean-to at the east end of the house. One chimney, ~~is~~ ^{inside} the east end of the roof. There is a porch on the north side of the house, and a smaller porch shelters the door of the lean-to on the south.
