**Description**

The Aberdeen Station building, constructed circa 1965, is a 1-story, hipped roof, brick building with a 1-story, side-gable addition. The deep eaves of the building serve as shelter for waiting pedestrians. Ribbon windows are located on the trackside and parking lot elevations of the building. Several windows are covered. An overhead door is located in the rear, parking lot elevation. There are two shelters, which provide access to the pedestrian tunnel, associated with the station which appear to date to circa 1950. Constructed of brick and wood with metal supports, the shelters could be the work of industrial designer Raymond Loewy. This designer and his firm were under contract with the Pennsylvania Railroad throughout much of the twentieth century. Beginning in the 1930s, Loewy and his associates designed everything from trashcans to the first streamlined locomotives for the railroad line. The shelters exhibit Loewy's streamlined design with the presence of a butterfly roof, deep eaves and open-air vents at the eaves. A small parking lot exists to the rear and sides of the building.

**National Register Evaluation**

The structures comprising Aberdeen Station are not eligible for the National Register of Historic Places. The buildings lack the exceptional importance necessary to meet the National Register's Criterion G consideration for buildings less than 50 years old. The buildings associated with Aberdeen Station do not well represent a historic event or trend that made a significant






