STATEMENT OF SIGNIFICANCE

The Bakers of Aberdeen, descendants of a colonial era Nicholas Baker, were perhaps the most prominent family in the Aberdeen area in the late nineteenth and early twentieth century. They were leaders in the canning industry, in government, the Methodist Episcopal Church, farming, banking and real estate. They built imposing Victorian residences in Aberdeen and established the local cemetery which bears the family name and contains a number of large monuments to mark their own final resting places ("The Baker Family of Aberdeen" by Jon Harlan Livezey, Harford Historical Bulletin No. 16).

The lots of Charles W., James B. and William B. Baker (this) were purchased in 1893 from the Aberdeen Land and Improvement Co. (Liber WSF 75 Folio 424) and all three houses were built soon thereafter.

The Baker house at 468 W. Bel Air Ave. is a large Queen Anne, two story frame residence with an attic, on a granite foundation. The irregular massing of the house is typical of the style. The first floor is covered with clapboards interrupted by vertical boards, suggestive of the frame of the house. The second floor is covered with fish-scale shingles; the change in texture is also typical of the style.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

One of three frame mansions built by sons of George Baker, first owner in Aarford County. Shingle and clapboard, 2½ and 3 stories under a slate roof.

The plan is complex ^{one} and ^{very open inside,} ~~as well as~~ the flexibility of the architecture of the late 1800's where central heating warmed the whole house, and the plumbing and lighting could be used in any design arrangements the architect chose.

Three porches include a double-decked porch at the front (north) and a wide one-story porch on the north and east sides. A captain's walk is at the peak of the hip roof. Wide dormers are as large as a gable end, and an octagonal cup rises from the north west corner three stories, topped by an octagonal ~~cup~~ pointed roof.
