DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ignatius Rutledge House is an abandoned two story frame house built about 1870-1880 with a later addition which is located about 300 yards east of the John T. Carter House (HA-783) on the same farm northeast of the Ferncliff subdivision near Rocks, Harford County, Maryland. The main elevation faces west.

The house appears to have been built in two stages. The first section has a four-bay, single pile plan with exterior end chimneys and a center staircase. Exterior doors on the west elevation open into both ground floor rooms. A shed porch with a concrete platform extends across the inner bays containing the doors. At a later date, a two-story addition of one room on both floors was built on the south gable end of the original section, enclosing the chimney on that elevation. The chimney on the north gable end remains exposed, with a rubble stone lower structure and a brick upper section and stack.

The window and door frames are plain and the remaining intact sash is 2/2. The porch roof supports have been replaced with untrimmed logs. The stone foundation is deteriorated in several places, particularly near the southeast corner, where a large break in the foundation opens into the cellar. The exterior is red-painted weatherboard and the roof is slate.

The interior walls are plaster over lath and are deteriorated in many places. The original section of the house has bull's-eye corner blocks at the door and window frames. The fireplaces have been closed and stove pipe openings are visible in the walls above the former fireplaces.

About 100 feet west of the house is a small square stone outbuilding, probably a smokehouse or meathouse. It has a single door on the south and exposed rafters with nails and hooks on the interior. The gable roof is slate and the exterior is plastered and whitewashed, although the plaster has deteriorated.

A frame bank barn with a stone and concrete block foundation is located approximately 50 yards south of the Rutledge House. It has machine-sawn structural timbers joined by mortise and tenon and the red vertical siding is also machine-sawn. The roof is slate. The barn appears to be somewhat newer than the house, perhaps dating from about 1890. The barn is still in agricultural use.

STATEMENT OF SIGNIFICANCE

The Ignatius Rutledge House is a good example of a late 19th century vernacular house, especially to compare with the early 20th century John T. Carter House (HA-783) nearby.

Ignatius Rutledge and his brother John inherited most of the present farm in 1807 from their mother, a daughter of Ignatius Wheeler, who had purchased the original tracts "Robert's Garden" and "Garden Fence" in the late 18th century. By agreement between the brothers, Ignatius became the owner of record, although this was not legally recorded until 1902 (see Chain of Title). Ignatius is shown as the owner of the house on the 1878 Martenet map. It is likely that each brother had a house on the farm, a theory supported by the ruins of a third house on the parcel which were located east of the Rutledge House, reported by the current owner. The ruins no longer exist.

The house is also shown on the 1858 Jennings & Herrick Map of Harford County. If the existing house dates from that period, it has been substantially altered, particularly on the interior.

CORRECTIONS AND ADDITIONS:

Section 7, Description:

The stone chimney is the only portion of the original Rutledge House still extant. The house was said to have 15 rooms in 1-1/2 stories. It may have been a telescope house, since it extended almost to the still-existing barn to the south. The house burned sometime prior to the Carter period of ownership (1902-1946). The Carters lived for some time after acquiring the property at the Wysong House (HA-1026), before erecting the Carter House (HA-783). They rebuilt the Rutledge House on a smaller scale than the original and used it for tenant housing. A second fire destroyed the Rutledge House and the existing structure is the third on the site.

"... Monica Rutledge nee Wheeler departed this life during the month of February 1807, leaving her two children viz. John W. Rutledge and Ignatius Rutledge who . . . were infants under the age of twenty-one . . . upon whom descended two of the hereinafter mentioned tracts . . . "Robert's Garden" and a part of . . . "Garden Fence" containing 211 acres. . . . John and Ignatius in their lifetime made a settlement between themselves for the said two tracts . . . Ignatius entered into possession and held possession up until the time of his death, but failed to have a deed recorded. Whereas, the said John W. and Ignatius Rutledge have since departed this life, the said John W. leaving . . . his only heirs at law, the said Charles A., John R., Martha J., Monica A., Henrietta M., and . . . Patrick H., . . . (who) has recently died unmarried and without issue; and Whereas, the said Charles A. (et al), having knowledge of said settlement between their father and uncle are willing to carry out the contract entered into by their father and to convey his interest . . . in . . . the said two tracts of land to his brother . . . and for the purpose of conveying any and all interests that they might have . . . join in this deed."

(NOTE: Joshua Rutledge may have been the son of Ignatius Rutledge. Joshua died in 1892 (Will Book JMM 11/270, 15 June 1892) and his wife Phebe died in April 1901 (Will Book GSN 12/340))



Martenet's Map of Harford County, 1878


