DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

718 N. Stokes Street is a rectangular brick house located on the corner of Hopper Alley, facing east. It is a simple town-house built in the Greek Revival Style, two-and-a-half stories high and five by two bays wide, with an all stretcher bond facade and common bond flanks. The house was until very recently divided into rental units.

Window openings on the facade (east elevation) are symmetrically arranged; those on the first and second floor having 1/1 light sash, while the row of small attic windows contain 6/6 lights. All the windows have narrow stone sills, painted white, with brick jack arches above them. The first window opening, north elevation, has been bricked in.

The entrance doors, located in the third and fourth bays, have identical modern enframements, classical in design with a plastic awning over them; a flat granite stone, in front of each door, serves as a low sloop. At an earlier date the central bay contained the entrance door while the bay next to it held a window.

The structure has a medium pitch gable roof with the ridge running north to south. Two large brick interior end chimneys rise from the middle of the north and south elevation walls. A cornice consisting of a brick dentil band painted white extends across the front of the house.

The dwelling has two asphalt-covered one story shed additions: one on the south elevation; the other extending across the rear west wall.

The Susquehanna River and the site of the Susquehanna and Tidewater Canal are located a block from the house.

Interior

At present the house is being converted into a single family dwelling. Its most recent use has been as rental apartments with a carryout food shop on the first floor, north side. Since every room is paneled, there is little evidence of how the woodwork and trim might have looked. However, the door enframements have architrave trim and there is an exposed fireplace on the north wall, first floor. A simple three-flight stair case rises to the attic, beginning on the south wall of the hall.

STATEMENT OF SIGNIFICANCE

The McCabe House is a plain 5-bay, two and a half story brick house, basically Georgian in plan, built in a vanacular Greek Revival style. The Greek Revival influence predominates in many of the brick houses in Havre de Grace; in this case, it is seen in the use of an all stretcher bond facade and the row of small attic windows under a plain brick cornice.

The house is important to community planning because of its location: the Susquehanna and Tidewater Canal Museum and park a block east of the house. In addition, as a masonry building it lends visual interest and variety to a neighborhood of predominantly frame dwellings.




