Frame and log construction in two varied parts to the house were both covered with clapboard and then asphalt shingle. L shaped.

The back wing facing north, is of log, 2 bays by 1, with two rooms on each of two floors divided by a wall that once contained a large cooking fireplace and chimney.

The new section is frame with high ceilings, 5 bays by 2 facing west, the roof ridge line running north-south with a small chimney ^{inside both} ~~at~~ end walls. A large dormer ^{with a small window odd space and light to the attic} over the center of the house. There is a one story porch across the front or west side of the house.




