

This frame farm house is very well kept.
~~It is a T shaped house with a chimney in the center of the main house and a chimney in the additional room to the east.~~
 T shaped, the main house (A) faces south across Deer Creek valley, with a hyphen and an additional room (B) to the east.

Two stories, four bays by 1. The wrap of two stories runs north from the center of the house, four bays by one. A chimney in the center wall suggests that one part (C) or the other (D) of the wrap is older—perhaps D was an outer kitchen connected later, or perhaps it was an addition.
