The property was most recently observed and photographed on June 26, 2003. The condition of the property appeared changed, with the complete demolition of the original dwelling and the subsequent construction of a new house from 1984 to 1987; since the preparation of the Maryland Historical Trust Inventory Form For State Historic Sites Survey, in the library of the Maryland Historical Trust.

The property is described in the Maryland Historical Trust Inventory Form For State Historic Sites Survey, prepared by Janet L. Davis, Historic Sites Surveyor, of Harford County Department of Planning and Zoning, in June, 1983.

As mentioned previously, the house described in the previous survey has been completely demolished and replaced with a modern house built between 1984 and 1987. Outbuildings observed included a deteriorated wood-framed shed with a slate gable



DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Lacey-Cummings House is a two-story frame house with a shed porch and exterior stone and brick chimney, built about 1885 on the north side of Boyd Road about 1/4 mile east of Ady Road (Maryland Route 543) near Ady, Harford County, Maryland. The house is presently unoccupied and somewhat overgrown with high grass. The main elevation faces south.

The main facade has three bays on the first floor and two on the second floor. The entrance is in the center bay. The porch has plain posts and simple brackets. The porch deck has been recently replaced with flagstones. The windows are 6/6.

On the north or rear side of the house is a shed addition with a concrete exterior chimney on the north end and a shed porch on its east side. The east gable end of the main section has the exterior stone and brick chimney, which may predate the house.

The foundation is stone and the exterior is clapboard, except on the rear wing which has german siding. The main roof is composition sheets and the porch roof is slate.

Several deteriorated outbuildings are located northwest of the house. The largest is a garage with a stone base and board and batten siding. This may have been a wagon shed prior to its used as a garage.

STATEMENT OF SIGNIFICANCE

The Lacey-Cummings House is notable primarily for its stone chimney, which appears to be a remnant of an earlier house on the site. Few houses of the late 19th century in Harford County have exterior chimneys of this type.

The Martenet Map of 1878 shows a house occupied by "C. Brown" in the vicinity of the present Lacey-Cummings House, supporting the possibility of an earlier house with the stone chimney. The chain of title shows that John F. Lacey acquired the property in 1885 in the settlement of an 1872 equity case. The Cummings ownership lasted from 1915 to 1937.





