

Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

The property was most recently observed and photographed on June 26, 2003. The condition of the property appeared unaltered but completely abandoned and derelict, since the preparation of the National Register of Historic Places Inventory - Nomination Form, in the library of the Maryland Historical Trust.

The property is described in the National Register of Historic Places Inventory - Nomination Form, prepared by Jean S. Ewing, of Maryland Historical Trust, not dated. Following is a brief summary of that property description, as modified by site observations made June 26, 2003.

The two-story farmhouse is oblong (4 bays by one, and is of frame clapboard construction on stone foundation. The ridge of the gable roof runs in an east-west direction and a brick chimney was observed in the central location of the roof. A


covered front porch on the north side, and wood single-hung windows were observed. The roof was observed to be clad with slate shingles.

The farmhouse was observed to be completely abandoned and derelict; with large areas of the walls collapsed, with windows and siding missing. Lush vegetation appeared to be consuming the structure. One of two deteriorated wood framed structures located to the northwest of the house is on the verge of collapsing, while the other has totally collapsed. Access to the property was difficult, as most of the concrete driveway to the property was missing and covered with overgrown vegetation.

The integrity of the property's design has been lost. It is not eligible for registration under Criterion C: Design/Construction, nor is it known to be associated with any event, person or archaeological significance that would qualify it for eligibility under Criteria A, B, or D, respectively.
