Mill used water from Falling Branch tributary to Deer Creek, Stone first floor, frame above with clapboard on second & third floors. Oblong, built into the bank, it is 2 or 3 stories high, 2 days by 0 downstairs. The millwheel remains on the east side <sup>4</sup> by 2 second floor <sup>3</sup> by 2 above. wall, and a block for the pulley to take in sacks of grain to the top floor. A chimney in the west end wall rises from a fire place in the ground floor. The A-roof ridgetime runs east-west.
