This small house in two parts has log construction in the larger section, 3 bays by 1, 1 1/2 stories.

The logs - exposed under the porch roof, are elsewhere covered first with horizontal siding, then with red asphalt shingles.

The A roof ridgepole runs east-west, the house faces south, the log section, east, has a one-story porch facing the south.

Oblong, about 15' x 12', there is a large chimney, brick, inside the west end wall.




