STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Once a warehouse along the old road from the Susquehanna bridge at Rock Run, the Bailey family converted this to a house about 90-100 years ago - George Bailey was also a carpenter and made caskets. His son was an undertaker in Darling ton between ^{abt} 1898 to 1950 ^(See NA 8). His daughter's family have lived here continuously.
