DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This one-story, store of frame finished in clapboard has two flat-roofed additions on either side of the original which faces south. The low-pitched A-roof ridge line running north-south. Originally oblong, the first addition to the east made it nearly square, the second oblong the other way. Both additions are used for wholesale storage and shelter for their truck. Two windows in the original store were 8 lights on S, and the double front door lighted with 6 panes each. Matching windows were added to the east addition. A porch shelters these 4 windows and the door.
