Roberts Mill, N.S. Bemis Mill
Broad Creek at Mill Green
Street, Maryland 21154

This rubblestone structure is located on the north side of Broad Creek, overlooking the village of Mill Green. The mill is at least the second one on this site. It is three stories high with an attic used as a fourth floor. The structure is three bays wide with doors located in the center bays of the south facade. On this, the creek side of the mill, there is a large stone medallion near the roof carved with the following inscription: "N.S. Bemis Mills 1827."

This mill is situated on the tract, "John's Adventure." The tract was a resurvey of the older "Ashmore's Choice" which incorporated the land upon which an earlier mill, "Ashmore's Mills," once stood. It is known that Ashmore's Mill was a voting center for Deer Creek Upper Hundred in 1775.

On May 11, 1821, a bond was recorded between John and Margaret Ashmore and their daughter, Susanna Bemis, and her husband, Nathaniel. This bond insured the Ashmores that they would be kept without worldly needs until their deaths. In the bond is a reference to the "house near the mill." The Ashmores deeded all their land, farms and the millbusiness to their daughter and son-in-law.

Thomas H. Roberts, Sr. purchased the property from Bemis in 1838. The mill continued to operate until approximately 1920.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This rubblestone structure is located on the north side of Broad Creek, overlooking the village of Mill Green. The mill is at least the second one on this site. It is three stories high with an attic used as a fourth floor. The structure is three bays wide with doors located in the center bays of the south facade. On this, the creek side of the mill, there is a large stone medallion near the roof carved with the following inscription: "N.S. Bemis Mills 1827."

The 1798 Tax List mentions a dwelling and a two story, stone, grist mill measuring 25 by 45 feet. This is very close to the present mill's dimensions and it is thought that the present mill was built onto in older Mill's foundations.

The insides of this grist mill were removed some time ago to make room for storage and a comfortable bath house.

Windows in the building are an unusual six lights over six: the upper sash is "vertical" with three rows of two panes in each. The lower sash has 2 rows with three panes in each.


