DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The farm house, clapboard covered, oblong, has three sections facing south, the pitched-roof ridgeline over each running east-west. Two parts have two stories, the east end, 3 bays by 1 and the next with one bay window by 1. At the west end a one-story section has 2 bays by 1, and, from the thickness of the walls and its general almost square proportions, may prove to have been an old log house, covered and incorporated.

Windows throughout have 6 lights over 6. A screened porch extends from the living room of the east section.
