DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This stone stuccoed house is in poor condition. ~~front~~ Oblong, 2 1/2 stories high, it faces west, the pitched roof ridge line running north-south. Windows and doors are unevenly spaced on the first floor under a one-story porch; four bays by two, it has three bays evenly spaced in the second floor. Three chimneys in the main house are unevenly spaced also, probably indicating addition to a smaller house.

A wing at the north end of the house, ~~an extension~~ <sup>an extension</sup> of the main house, is ~~one~~ 1 1/2 - storied with very asymmetrical spacing of the door and window in the first floor, the dormer in the second. A fourth chimney rises from the end wall.
