Laundromat now downstairs.</p> <p>Evidence of the prosperity of the town was the week-long entertainment Lyceum, a traveling show of drama, singing, vaudeville jugglers etc. that sold season tickets to their show twice a year. The town also scheduled basketball tournaments for men and women.</p>


