This is a two story frame dwelling, three bays by two. The house faces west toward Broad Creek and the Mill Green Mill.

The village of Mill Green grew up around the once prosperous grist mill located on Broad Creek. The mill, built in 1827 by N.S. Bemis, to replace an older stone mill, remained in operation until approximately 1915.

Houses in the village of Mill Green reflect that era when the mill was known as Robert's Mill and owned and operated by Margaret Street (nee Roberts). Joseph Boyd is listed as her miller in the 1878 Business Directory.

At one time this village had a tavern, post office, saw mill, grist mill, forge, general store and hotel.

The house has a gable flank, slate covered roof. A brick chimney is located at the inside south end. Windows through most of the house are two lights over two. There are four windows at the second level of the house.

The principle entrance is located in the north west bay of the west facade. A one story porch is located on this facade. It has turned columns and a hipped roof covered with slate shingles.

A story addition on the east has a one story, enclosed porch on its south facade. A brick chimney is located on the east inside end of this unit.
