Stone masonry walls and a slate roof are the enduring materials of this abandoned farmhouse facing south 3 bays by 1. The roof/ridge line runs east-west. Windows and doors are gone from their pegged oak frames, floors uprooted by ground heaves. Two visible flued chimneys rise from large fireplaces on each floor at the end walls.
