DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Large stone Victorian mansard house, bracketed, with a slate and rolled copper roof. L shaped, its two wings appear to have equal importance, 5 bays by 2 ~~bays~~, three stories left, it faces east and south with a one-story porch on these two sides.

Windows have 2 lights over 2 except in a bay-window in the west end wall where three smaller windows are 1 over 1.

Dormer windows in the third floor are under a low-pitched peak, and have gable ends at the sides. The cornice is bracketed, the wide porch, with pillars in pairs, was stick decoration.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Built by the Jenkins family of Baltimore for their summer place, this is now owned by the Todd family of farm managers.

It was discovered by neighbors that the Jenkins, however aloof, were Welshmen like many of themselves when a family Bible "in an unknown language" turned up in the house at the death of Mr & Mrs Jenkins. The Bible was written in Welsh, as discovered by banker Robert Lloyd of Delta-Cardiff.
