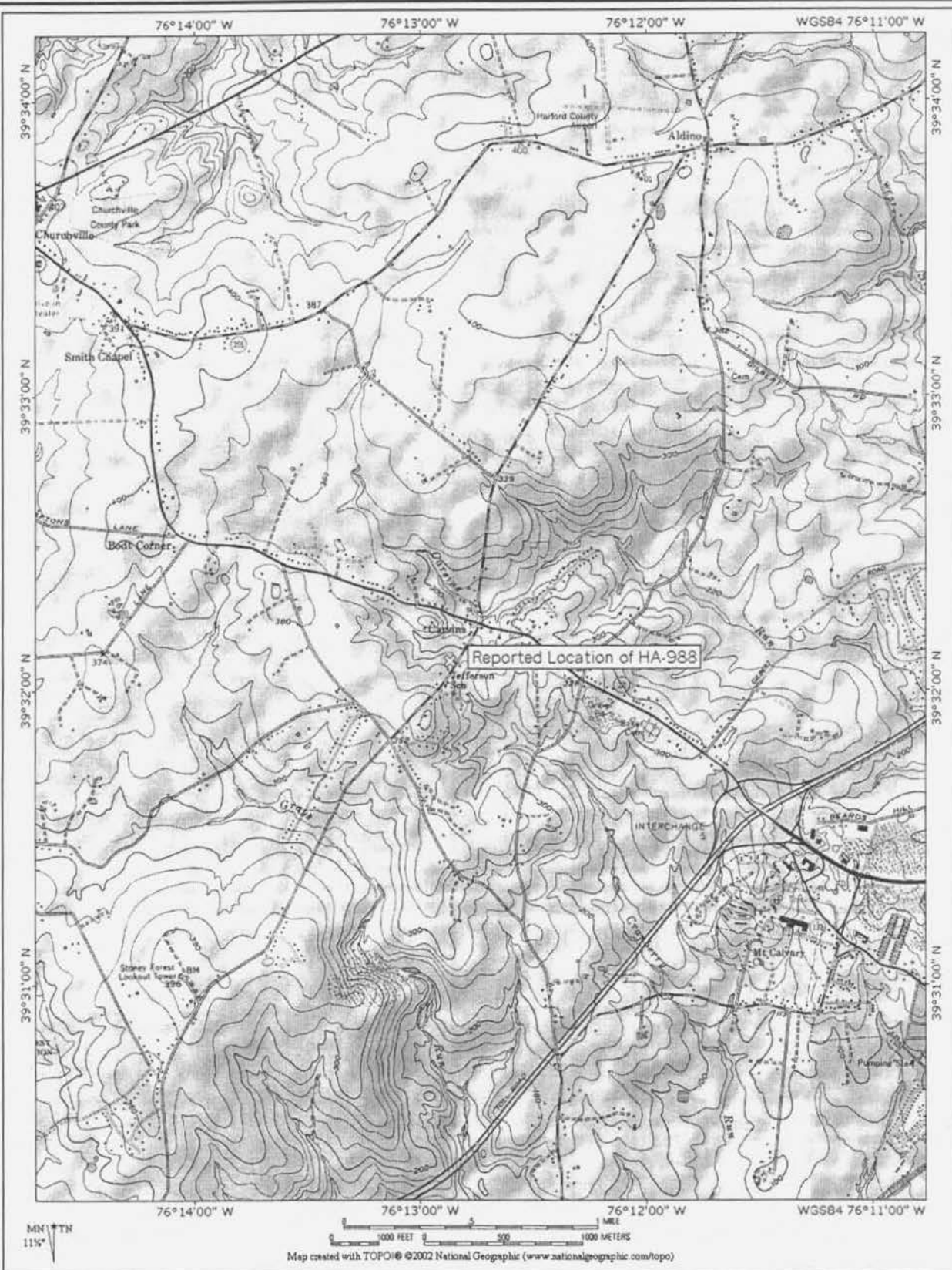

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Located on the west side of Carsins Run Road, south of Churchville Rd. (Md. Rte. 22), this frame saltbox house faces south with the one-story addition on the north. Set on a stone foundation and covered in asphalt shingles, the building has an interior brick chimney in the east end and an exterior brick chimney on the west end. (The rear addition has a cement block foundation.) The south side and east end have entrance porticos-the latter with a gable roof, the former with a hipped roof. The fenestration is varied: the north and south facades have sash windows with three vertical lights over one light; the west end has a 6/6 sash window.

STATEMENT OF SIGNIFICANCE

This structure may be the building listed on the 1878 Martenet's Map as belonging to J. T. Akers. The asphalt shingles and early 20th century window sash, however, belie a mid-19th century date. Without examination of the interior, the origins of this house are impossible to establish. Neither is the situation amplified by the configuration of the structure. Three bays wide and one room deep with an apparently recent saltbox addition, the house could date to anytime from the early 19th century to the early 20th century.

The east end wall has a chimney inside rising from a fireplace now blocked off. A flue rises outside the west end wall from a kerosene heater. There is no plumbing, but an air conditioner is in the window. Windows have a variety of sashes - 3 over 1, 6 over 6, or 1 over 1, with a 3 light rosement sash in the second floor. </p>

This is similar to some of the earliest small houses built as Harford County just became settled. The roof may have extended out over the south ~~side~~ wall ^{sheltering} ~~making~~ a front porch. Worthy of investigation as one of Harford's earliest ("frontier") cottages.
