DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Set back from the Aberdeen-Churchville Road, this frame clapboard farmhouse is one of a half-dozen or so that is L-shaped, but with a side-hall plan in the main house. Two and a half stories high, it is nearly square, 3 bays by 3, while the two storied wing is oblong, 3 bays by 0. The A-roof ridgeline runs east-west in the main house, north-south in the wing.

The house would appear to face north, but that door is shuttered and there are no steps. The entrance is now in the east wall under a Greek-revival portico with four fluted Doric columns. Windows have 6 lights over 6. There are two chimneys inside the west end wall rising from heating fireplaces upstairs and down. A large central chimney in the wing rises from a cooking fireplace now blocked off for flues from the cookstove and the furnace.
