This house is a conglomerate of three buildings connected by a lean-to section. (see sketch) One or more may be of log construction, with clapboard covered by asphalt shingles. All three parts face west.

The main house ^{lying to the south, is} ~~is~~ three stories high, 3 bays by 2. ~~Connected to the west~~

~~at the west end~~ ^{Next} is a two storied section, 2 bays by 2. A wide lean-to connects a third part ^{lying to the east,} ~~the toe of the L,~~ two stories high, 1 bay by 1. These three parts have pitched roofs. ~~with~~ ^{with} ~~ridgelines~~ ^{ridgelines} running north-south. There are two chimneys, one inside the south end wall of the south section, one inside the north end wall of the north section.

Windows downstairs are generally 6 lights over 6 with some 2 over 2 in the middle section. windows under the eaves have small sashes 3 lights over 3.

A one story porch shelters much of the west and south sides of the house, and adds some gingerbread trim, to a house whose main interest may be the heavily-covered building material.
