The William Johnson House faces west on the east side of Manor Lane.

It is a three bay wide, one bay deep, two story high, gabled roof (running north-south) frame (covered with asbestos shingles) house, resting on a stone foundation, with a two bay wide, one bay deep, two story high, intersecting gable roof (running east-west) frame (covered with asbestos shingles) service wing, resting on a stone foundation, constructed on the north side of the main building block's east wall, creating an "L" plan.

The wide central brick chimney is usually associated with early buildings. No building, however, is noted here on the Martennet Map of 1860 or The Hopkin's Atlas of 1878. As a dependency of Doughoregan Manor, the building may well have been omitted and so be of earlier vintage than noted.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The William Johnson House faces west on the east side of Manor Lane.

It is a three bay wide, one bay deep, two story high, gabled roof (running north-south) frame (covered with asbestos shingles) house, resting on a stone foundation with a very wide central brick chimney, and a two bay wide, one bay deep, two story high, intersecting gable roof (running east-west) frame (covered with asbestos shingles) service wing, resting on a stone foundation, constructed on the north side of the main building block's east wall, creating an "L" plan. A one story high, hipped roof, open porch runs along the east wall of the main building block.

WEST FACADE

The west facade features a rectangular central entrance covered by a gabled roof portico, flanked by a double-window, each component a rectangular, double-hung window, holding two-over-two lights. Two gabled roof, dormer windows at this elevation hold rectangular, double-hung windows with two-over-two lights. The wide central, brick chimney completes the building profile and may indicate an early construction date.

STATEMENT OF SIGNIFICANCE

The William Johnson House stands on land, once a part of Dough-oregan Manor on the east side of Manor Lane, but is noted on neither the Hopkin's Atlas of 1878 nor the Martennet Map of 1860. As a dependency of the Manor however, it may have been omitted and so be of earlier vintage than indicated.

Architecturally, it is noteworthy for its wide central brick chimney, which often indicates an early building date.

The William Johnson House is also important to Howard County and the State of Maryland as representative of Howard County, one story high, vernacular frame architecture, with the roof raised at a later time and dormers added to create more workable space. Such buildings, often first constructed in an "I" plan, with later additions, creating "L" and "T" plans, are important to record as a part of a compendium of Howard County architectural history.




