These two connecting stone buildings, which together comprise an "L" plan were once used as auxiliary buildings for Oakland Manor as a blacksmith shop.

A two bay wide, one room deep, one story high, gable roof (running east-west) stone (featuring stone quoining) building, resting on a stone foundation, with square stone chimney inset into its west wall connects to a west wing, comprised of a two bay wide, one bay deep, one story high, gabled roof (running north-south) stone (covered with stucco) building, resting on a full story stone foundation, projecting slightly southward from the south wall of the east wing.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Oakland Manor Blacksmith Shop faces south on the southeast corner of Hyla Brook Road and Pasture Gate Lane. It is a two bay wide, one room deep, one story high, gabled roof (running east-west) stone (featuring stone quoining) building, resting on a stone foundation, with square, stone chimney inset into its west wall. To the west wall of this stone building rests a two bay wide, one bay deep, one story high, gabled roof (running north-south) stone (covered with stucco) west wing, resting on a full stone foundation, projecting slightly southward from the south wall of the east wing.

A one story high, one bay wide, shed roof addition, runs along two thirds of the north wall of the east wing.

THE SOUTH FACADE

The south facade holds a centrally located, rectangular, paneled entrance door. West of this entrance is a very large, rectangular, picture window, holding twenty lights, with four lights on each side opening as a casement.

The south elevation of the stuccoed west wing holds a first floor, rectangular, double-hung window, holding six-over-six lights, vertically aligned to a similar foundation window, originally fully exposed.

THE NORTH ELEVATION

The north elevation of the east wing stone building holds no apertures. The shed roof addition, which takes up two thirds of this stone building's north wall, connecting to the east wall of the west wing of the building, and lying flush with its north wall, holds a rectangular, double-hung, window on the west side of its north wall. A small rectangular, three light foundation window is placed on the east side of this wall.

The north wall of the west wing holds a central, rectangular, double-hung window, holding six-over-six lights. East of this window a smaller, rectangular, double-hung window is placed, holding two-over-two lights.

THE WEST ELEVATION

The west elevation holds two rectangular, double-hung windows, holding six-over-six lights.

THE EAST ELEVATION

The east elevation of the east wing stone building holds an eight light, rectangular window, three lights of which are used as a casement window. It is surmounted by a flat wooden lintel. A cement water table runs along the elevation.

The east elevation of the shed roofed addition holds a four-light, rec-

tangular, open bible and cross paneled entrance door.

The interior of the house holds one large living room, which takes up the entire floor area of the east wingstone building and has been completely modernized. The west wing holds a hall, off which are two bedrooms and a bath. The shed roof addition holds the kitchen unit.

STATEMENT OF SIGNIFICANCE

The Oakland Manor Blacksmith Shop Building. This building comprised two stone sections forming an "L" plan and is said to have been the Blacksmith Shop for Oakland Manor. Since it lies so close to what some local historians believe to be the Old Oakland Manor House, it is conceivable that this building dates from that period. It is probable that by 1830 or early 1840, the buildings existed, though no dependencies are shown on either the 1860 Martennet Map or 1878 Hopkin's Atlas. The building is closely associated with the history of Oakland Manor and most recently has been used as the first post office in Columbia, Maryland. It now serves as a residence.

As one of three old stone buildings adjoining one another and surrounded by the residential neighborhood of the Birches, in the new town of Columbia, Oakland Manor Blacksmith Shop Building should be considered for inclusion to the National Register of Historic Places, the State Critical Areas Program and any local landmark ordinance, the citizens of Howard County might seek to initiate, should its owners so desire.

Savage, MD. Quadrangle


