The north elevation transomed center door is flanked by windows of 2/2 pane sash. At the 2nd floor level are five windows. There is a small shed-roofed porch centered with simple square posts.

The roof plan is an A frame with simple and almost unnoticable gable returns. There are stove chimneys at either end. A rear wing extends to the south.

The house has now been demolished.




