7.1 Description

Exceptionally large for a log house, this building, almost square, covered with clapboard, has lost a large section of its foundations at the rear and is in imminent danger of collapse. The house faces north onto Frederick Road. Four bays by two, 2 1/2 stories high, a large cross-gable style peaked dormer with sawtooth decoration at the cornices has been added to the north slope of the roof. Exterior chimneys raise to the peak at each end of the house from heating fireplaces. The first floor front elevation contains two doors and two sets of 6/6 sash windows. At the second floor level are four windows containing sash of 2/2 panes. The full-length shed-roofed porch has square posts with Victorian brackets at the eaves.

Numerous alterations include removal of partitions to the interior, erosion of the cellar walls, exterior and interior, and changes in some windows from 6/6 to 2/2 lights, as well as a partly removed chimney with a tin flue replacing the top 12'-20' of the stack.

If bearing log walls have been allowed to deteriorate this may be a hopeless restoration job.

HO 203 is a ~~log~~ ^{log w/ clapboards} frame dwelling of two story height with the facade at the N. elevation. The A frame roof has a centered cross gable with a wood sawtooth decoration at the corners.

The dwelling is four bays in length possessing two windows of 6/6 pane sash and two slightly recessed doors. At the 2nd floor level are four windows containing sash of 2/2 panes. The full length shed roofed porch has square posts with Victorian brackets at the eaves.

at both the E. and W. ends are single exterior ~~chimneys~~ ^{w/ stacks} flush to the gable wall. Each has a single water shelf on their S. wall. The stack of the W. chimney has been removed (or fell) and has been replaced by a tin stove chimney.



MARYLAND HISTORICAL TRUST - HISTORIC SITES SURVEY




