The Dundee Smokehouse is a square, one story high, tent roofed granite block (featuring stone quoining) building, located just west of the main house.

It holds central, rectangular, louvered openings, surmounted by flat stone lintels and underlined by projecting stone sills, on its east and south elevations. A rectangular, battonwood entrance door is centered on its north wall.

This well constructed building is associated with Dundee, notable as the home of Sarah Bland Mayo and her husband, Commodore Isaac Mayo, one of the four founders of the United States Naval Academy at Annapolis and of Mary Temple and her husband, Dr. Thomas Temple, who distinguished himself as a physician in the Confederate army and is believed to have been the personal physician of General Robert E. Lee.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Dundee Smokehouse is a square, one story high, tent roofed, granite block (featuring stone quoining) building, located just west of the main house.

It holds central, rectangular, louvered openings, surmounted by flat stone lintels and underlined by projecting stone sills, on its east and south elevations. A rectangular, battonwood entrance door is centered on its north wall.

The floor of the interior of the smokehouse is of brick, with a two foot ledge running from the floor around the perimeter of the room. Fires were evidently put along its sides with smoke escaping through a pipe found at ground level. Meat was said to smoke for three days.

STATEMENT OF SIGNIFICANCE

The Dundee Smokehouse is an excellent example of the square, tent roofed, ashlar granite block, stone smokehouses, which can be found in Howard County, Maryland, and which is associated with HO-211, Dundee, a transitional Federal style building.

HISTORY AND SUPPORT

The Dundee Smokehouse is an excellent example of nineteenth century stonework, executed by master craftsmen, constructed of ashlar, granite blocks and featuring fine stone quoining, projecting stone sills and flat stone lintels.

For a discussion on the significance of Dundee in the areas of architecture, the military and education, please see Section 8, Significance, of HO-211, Dundee.





SECOND DISTRICT

Scale 2 Inches per Mile


