The Joggereit House faces north on the south side of Route 144, just west of the Ridgely-Mercier House, HO-249. It is a three bay wide, one room deep, two story high, gabled roof (running ~~east-west~~) log (covered with mustard colored aluminum siding) house, resting on a stone foundation, with square brick chimney inset into its west wall.

Its north elevation holds a central cross paneled entrance door, flanked by rectangular, double-hung windows with two-over-two lights and two second floor, vertically aligned windows in the end bays.

A very early, two bay wide, one room deep, two story high, intersecting gable roof (running north-south) frame south wing with central square brick chimney extends south from the west side of the log buildings south wall.

Excellently maintained and surrounded by flower gardens and lovely lawn, this century old log house is one of Lisbon's finest landmarks.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Joggereit House faces north on the south side of Route 144, just west of the Ridgely-Mercier House. It is a three bay wide, one room deep, two story high, gabled roof (running north-south) log (covered with mustard colored aluminum siding) house, resting on a stone foundation. It's north elevation holds a central cross paneled entrance door, flanked by rectangular, double-hung windows with two-over-two lights and two second floor vertically aligned six-over-six light windows above. Its west wall holds an interior central, square brick chimney and second floor six-over-one light window. The east elevation of the house holds a two over-two first floor window and six-over six light second floor window with central four light attic casement window above.

Very early, a two bay wide, one room deep, two story high, intersecting gable roof (running north south) frame south wing with square central brick chimney was constructed, extending south from the west-side of the log building's south wall. Its west elevation holds two six-over-six light second floor windows and a first floor six-over-six light window to the north with a double one-over-one light (obviously a recent twentieth century addition) double-hung kitchen window to the south. The east elevation holds two six-over-six light rectangular, second floor windows and a one story high, shed roofed enclosed porch. A rectangular entrance door to this porch is flanked by a single double window, each component a double-hung window, holding one-over-one lights. A further one story high, shed roofed addition runs along the south wall of the south wing kitchen - dining room addition. Its south elevation holds a rectangular entrance with a double window, similar to those on the east wall of the enclosed porch, east of the door and a one-over-one light rectangular window west.

This entire house has a compact and well maintained unity. The architectural integrity of this fine log house, its modest scale, as well as its excellent maintenance and usefulness as an architectural link between the Mercier Home to its east and the Esworthy Log House to its west serve to make it one of Lisbon's most important houses.

STATEMENT OF SIGNIFICANCE

The Joggeriet House is significant architecturally and historically to the town of Lisbon and the state of Maryland.

Architecturally, the Joggereit House is representative of the two bay wide, one room deep, two story high log structures, built in Lisbon in the early 1800's after the survey by the town on July 4, 1811 by Caleb Pancoast. Some six other log houses remain. They are the Esworthy Log House, just west of the Joggereit House, the old Methodist Parsonage, H0-198, on the southwest corner of the intersection of Route 94 and Route 144, Buckingham House H0-247, located just east of the small frame Power's House, all of which are located on the south side of Route 144. Noah's Ark, known as the Emerson Picket Log House was dismantled in 1973 and the Misses Warfield House, H0-233 was moved south to its present location as the Snyder Piano and Organ Shop. Log kitchen appendages are noted on the north wall of the Mathis Frame House, H0-201, located on the north side of Route 144 and on the north wall of the Mayne Brick-Log House, H0-202. located just east of the Mathis House.

The Joggereit House is architecturally noteworthy, as one of the some half dozen or so old log homes which were constructed in the early nineteenth century and which remain standing today in the old village of Lisbon.

In addition to its individual architectural integrity, this exceptionally well maintained property serves as an important architectural link between the Esworthy Log House west, and the Ridgeley-Mercier House, H0-249 east, in the streetscape on the south side of Route 144.

Historically the ownership of this quaint, charming house can be traced back to Elizabeth Garret who on the 26th of May, 1845, conveyed the house and lots 40 and 90 to Rache Bosley "in consideration of long and continued acts of friendship and kind service and also in consideration of the sum of one dollar." (Howard County Land Records Liber 5, folio 496) The 1860 Martennet Map indicates it as the residence of M.E. Bosley. Three further owners held the property between 1850 and 1869, when Julia A. Chambers conveyed the property to Elizabeth Fisher, whose husband Joshua Fisher appears as owner of these two lots, 40 and 90, on the 1878 Hopkins Atlas (Liber 29, folio 311, Howard County Land Records.

Architecturally and historically noteworthy, the Joggereit House, along with the entire village of Lisbon should be placed on the Nation Register of Historic Places.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This frame clapboard house is L shaped, 2 stories high, facing ~~west~~ 3 bays by 1 with 2 bays by 1 in the wing running south along the west end wall. The A-frame roof/ridge line runs east-west, with fairly wide eaves and a boxed cornice. One chimney rises inside the west end wall, one is in the wing rising from an interior wall.

Windows of stairs are 6 lights over 6, downstairs 2 over 2 except in an area enclosing the side porch of the wing, 1 over 1. There is a front porch across the north side of the house.




 THE JOGGERIT HOUSE






