Tuten's Cottage faces west on the east side of Old Columbia Pike in front of Broxton. It is a two bay wide, one room deep, two story high, gabled roof (running north-south) brick (laid in English garden wall brick bond) house, resting on a stone foundation with wide brick chimney inset into its south wall, measuring only 16 feet by 16 feet.

Three wide, poured-in-place, cement steps lead to the rectangular, nine light, cross paneled, entrance door in the north bay of its west elevation, covered by a gabled roof hood. A rectangular, double-hung window, underlined by flat wooden sills, rests in its south bay, with two vertically aligned, proportionally scaled, second floor windows above. The door and windows are surmounted by stretcher brick, flat arched lintels. This elevation features a simple box cornice. The stone foundation for this building is a very deep one, rising to the first floor on the north, south and east elevations.

Tuten's Cottage is a good example of a small, two bay wide, two story high, gabled roof brick building, which is found in Ellicott City, and which is associated with the James Lea and the Isaac family of Ellicott City, Howard County, Maryland.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Tuten's Cottage faces west on the east side of Old Columbia Pike in front of Broxton. It is a two bay wide, one room deep, two story high, gabled roof (running north-south) brick (laid in English garden wall brick bond) house, resting on a stone foundation with wide brick chimney inset into its south wall, measuring only 16 feet by 16 feet.

Three wide, poured-in-place, cement steps lead to the rectangular, nine light, cross paneled, entrance door in the north bay of its west elevation, covered by a gabled roof hood. A rectangular, double-hung window, underlined by flat wooden sills, rests in its south bay, with two vertically aligned, proportionally scaled, second floor windows above. The door and windows are surmounted by stretcher brick, flat arched lintels. This elevation features a simple box cornice. The stone foundation for this building is a very deep one, rising to the first floor on the north, south and east elevations. The north elevation holds only a rectangular attic window, which appears to hold six lights, covered by a screen. The south elevation holds a rectangular entrance door in its west bay and a small rectangular attic window west of the brick chimney.

The east elevation holds a dilapidated wooden staircase to a second floor, shed roofed open porch and landing in front of its north bay entrance. A second floor window, similar to those already described, lies south of the door. This elevation also indicates the ground floor stone wall for the building, which once existed here. Since the house is located on a steep slope of land, its east elevation, second floor is more like the first floor.

The building has recently been hit by a car in its southwest corner, causing severe damage to the brick work at this corner and needing immediate attention or demolition for safety.

STATEMENT OF SIGNIFICANCE

Tuten's Cottage is a good example of a small, two bay wide, two story high, gabled roof brick building, which is found in Ellicott City,¹ and which is associated tiwh the James Lea and the Isaac family of Ellicott City, Howard County, Maryland.²

Explanatory Notes

1. Tuten's Cottage is very similar to one found south of Merryman and Hill Streets in Ellicott City, on the west side of the Cat Rocks Creek, believed to be associated in some way with an old quarry further south. Tuten's Cottage and this latter building are of the same dimensions, are two bays wide, one room deep and two stories high. Staircases are located in the corner next to the entrance door, with a wide brick chimney placed on the opposite wall. Constructed of English garden wall brick bond, they rest on substantial stone foundations. Ellicott City is noted for its stone buildings, with a scattering of brick, such as we find in Tuten's Cottage.

2. The history of Tuten's Cottage is presented in the deed description of the property, where it mentions the "southwestern wall of the

gable end of a brick house built upon the lot now being described by James Lea" and previously "the whole lot conveyed by Thomas Isaacs to James Lea, dated March 3, 1838" and recorded in Liber WS6 22 folio 572 of the Anne Arundel County Land Records. We thus know the builder, James Lea and the man who sold him the property, Thomas Isaacs, the latter of whom owned other property in Ellicott City as well. This first parcel, on which the house stands, was evidently once a part of "Prestiges Folly".

By 1860 the property had come back to the Isaac family for Zedediah M. Isaac in his will of 1890 mentions acquiring it in 1860 from Mr. David B. McLaughlin. In that will he devised the property to his son, William Moore Isaac, to be held in trust by him for the use of his daughter, Mary Gertrude Sunderland. In 1919, Tuten's Cottage became the property of this woman's three sons, Herbert, Edmund and Benjamin. In 1956, Warren Lee Plunkert became the owner of this small brick house. Three years later it was acquired by its present owner, Mrs. Catherine Tuten.

Recently, the southwest corner of the building has been struck by an automobile, causing breakage in the brick wall and a general collapse of the building. It is hoped that this can be repaired or the property on which it stands sold to someone interested in restoring and rehabilitating this early, modest brick buildup.


PARCEL 1 pertaining to Prestiges Folly "the beginning

September 4, 1890 - Wills T.S.3, 189-191 Will of Zedekian M. Isaac

July 19, 1892 in item 4 "I give devise and bequeath to my said son William Moore Isaac in trust and confidence to be held by him for the use of my daughter Mary Gertude Sunderland all that piece of land with the improvements describe in a deed from David B. McLaughlin to me dated June 11, 1860 25-227 and also all that other piece or parcel of land and improvements thereon being part of the land devised to me by Thomas Isaac by last will & Test. except that part thereof described in the devise to William Isaac.

Deed fr. Rachel Strandley to Thomas Isaac Feb. 16, 1838 - AA23-124 (13-301) "the fense now stands which divides the gardens of messrs Rumstone and McKenzie, tenants on the property, thence westerly with said fense as it now stands to a granite stone planted by me 5' distance from the northeast corner of the Kitchen of the dwelling occupied by Mr. Rumstone thence in a straight line to the southeast corner of the frame bldg used as a woodshed by said Rumstone

PARCEL 2 includes that strip of ground Easterly of and ~~bordering~~ on the Columbia Turnpike Road reported to have been used formerly as a private roadway along the south easterly side of the lot of ground of Parcel 1. - the roadway lies adjacent thereto and between it and the property once owned by Dr. Samuel Owens and as of the date of this deed owned by Catherine M. Tuten and William Tuten 187-483. (This property is known as Broxton) containing in deed of 1945 (187-483) 20.5/10 acres of land.

 Tax Map 25-A


SECOND DISTRICT

HOWARD COUNTY


