The Lisbon Fire House Building

This building faces north, just west of HO-205, Lee's Store and House, on the south side of Route 144. It is a four-bay wide, five-bay deep, single story high, gabled roof (running north-south) cinderblock and frame (covered with asbestos tile) building, resting on a stone covered with cement foundation. A shed roofed, one story high, open portico, supported by two square posts, resting on a cinder block, three foot high wall in front of the north facade, covers the twelve light, rectangular entrance located in the second west bay of this elevation. Fenestration is entirely rectangular, and double-hung, holding two-over-two lights on the east and west walls and six-over-one lights on the buildings' north wall.

Shed roofed, one story high appendages lie off the south wall of this relatively modest structure, which between circa 1949 and 1960 housed the Lisbon Volunteer Fire Department.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Fire House Building is located just west of HO-205, Lee's Store and House. It is a four bay wide, five bay deep, one story high, gabled roof (running north-south) cinderblock and frame (covered with asbestos tile) building, resting on a stone, covered with cement, foundation. A shed roofed, one story high, open portico, supported by two square posts, resting on a cinderblock, three foot wall in front of the north facade, covers the twelve light, rectangular entrance, located in the second west bay of this elevation. A six-over-one light rectangular, double-hung window rests west of it and two six-over-one light, narrower, rectangular windows east of the door.

The west wall of the building features four two-over-two light rectangular, double-hung windows and a smaller, but similar one in the south bay of this elevation. This latter bay appears to be an addition, resting on a cinderblock foundation, while the rest of the building rests on a stone, covered with cement foundation.

The south wall holds two one story high, shed roofed, cinderblock and frame appendages, on the east, featuring two horizontal rectangular one light windows, located near the eaves on its south wall.

The building's east elevation holds four similar windows to those on the west and a four light, rectangular entrance in the north bay of this wall.

The building is in fine condition and is presently used as a residence, where formerly it housed the Lisbon Volunteer Fire Department from circa 1949 to 1960.

STATEMENT OF SIGNIFICANCE

The Lisbon Fire House Building is significant to the town of Lisbon architecturally and historically.

Architecturally it promotes the human scale experienced in this early nineteenth century town of Lisbon, providing a visual link between the Engle House and Lee's Store and house on the South side of Route 144 and is important historically to the town for housing its Volunteer Fire Department circa 1949 to 1960.

In 1856 the land on which this building is located, was acquired by William Engle who at about that time built his house on the middle line of lots 31 and 32. A part of this building may have existed at that time or later when it became part of the Delashmutt family holdings, which included HO-205, Lee's Store and House.

On May 3, 1926 (127-432) Frank and Lena Delashmutt conveyed this property to Charles and Agnes DeLashmutt. On October 29, 1949 it became the property of the Lisbon Volunteer Fire Company and remained so until November 12, 1960 when it was acquired by J. Thomas and Bessie Sullivan. It is presently owned by Mr. and Mrs. Charles Brown (663-697.)

Of interest historically, and architecturally significant to the streetscape on the South side of Route 144, the Lisbon Fire House Building, along with the entire early nineteenth century town of Lisbon, should be placed on the National Register of Historic Sites and State of Maryland Critical Areas Program.






Lisbon Fire House Building
